

REGULAR MEETING OF THE COMMON COUNCIL OF THE CITY OF PLATTSBURGH,  
NEW YORK, HELD SEPTEMBER 23, 1965.

PRESENT: ALDERMEN BOOTH, BEAUVAIS AND DUKEN AND MAYOR TYRELL.

ABSENT: ALDERMEN SABOURIN, BRANON AND FLYNN.  
LOCAL LAW NO. 10 OF 1965

BY ALDERMAN DUKEN; SECONDED BY ALDERMAN BOOTH:

A LOCAL LAW AMENDING LOCAL LAW NO. 12 OF 1964, AND LOCAL LAW NO. 4 OF 1965, BY AMENDING THE CO-OPERATIVE AGREEMENT SET FORTH IN SECTION 1 OF SAID LOCAL LAW, AND IN THIS INSTANCE PROVIDING THAT THE MEMBERSHIP WILL CONSIST OF NO MORE THAN 60% REPRESENTATION FROM MAJOR PUBLIC AND PRIVATE AGENCIES, AND THAT 40% OF THE SAID COMMISSION SHALL BE PARTICIPANTS.

BE IT ENACTED BY THE COMMON COUNCIL OF THE CITY OF PLATTSBURGH,  
NEW YORK AS FOLLOWS:


SECTION 1: PARAGRAPH ONE OF THE CO-OPERATIVE AGREEMENT SET FORTH IN SECTION 1 OF LOCAL LAW NO. 12 OF 1964 IS HEREBY AMENDED TO READ AS FOLLOWS:

1. THERE SHALL BE ORGANIZED BY THE CONTRACTING PARTIES HERETO, A JOINT ECONOMIC OPPORTUNITY COUNCIL, WHICH SHALL CONSIST OF TWENTY-FOUR (24) MEMBERS, OF WHICH THE MAYOR OF THE CITY OF PLATTSBURGH AND THE CHAIRMAN OF THE BOARD OF SUPERVISORS OF CLINTON COUNTY, SHALL BE EX-OFFICIO MEMBERS AND TWELVE (12) OF WHICH MEMBERS SHALL BE APPOINTED BY THE MAYOR OF THE CITY OF PLATTSBURGH AND TWELVE (12) OF WHICH SHALL BE APPOINTED BY THE CHAIRMAN OF THE CLINTON COUNTY BOARD OF SUPERVISORS. THE CHAIRMAN OF THE COUNCIL SHALL BE APPOINTED BY THE MAYOR OF SAID CITY AND THE CHAIRMAN OF THE BOARD OF SUPERVISORS, AFTER SELECTION BY THE FULL COUNCIL. THE JOINT COUNCIL WILL AT ALL TIMES BE COMPOSED OF 40% RESIDENT PARTICIPANTS AND NO MORE THAN 60% REPRESENTATION FROM MAJOR PUBLIC AND PRIVATE AGENCIES.


SECTION 2: THIS ACT SHALL TAKE EFFECT AFTER A PUBLIC HEARING AND APPROVAL BY THE MAYOR.
