TERMS OF PAYMENT

Except as shown under "Special Provisions" below, meters are read and bills after rendered once every three months in arrears. The net amount is due when bill is rendered. Gross amount shall be due after date shown on bill.

TERM:

From the date of commencement of service, pursuant to application, until 10 days written notice is given prior to the date set for discontinuance or upon discontinuance by the Sewer Department in accordance with the provisions of this Schedule of Sewer Service.

SPECIAL PROVISION:

All those customers who do not have water meters installed in the water service line serving their premises on the effective date of this service classification shall be billed at the rate of \$18.64 per month thereafter until such time that a water meter has been set in the water service line to their premises. Thereafter, the rates for sewer service above set forth shall apply.

Bills may be rendered monthly at the option of the Sewer Department. Where bills are rendered on a monthly basis, one-third of the above quantities will be used in computing the charges for the various steps. The terms of payment for monthly billings are twenty days after date of bill. Gross amount plus interest shall be due thereafter.

Elderly persons that qualify for the Real Property Tax Exemption shall also be exempt from the minimum charge for Sewer Service and be charged for only the actual gallons of sewage discharged as measured by the water meter readings.

**SECTION 2: LAWS REPEALED**

All acts pertaining to sewer rates and regulations heretofore enacted and inconsistent in whole or in part with this local law are hereby repealed.

**SECTION 3: TIME OF TAKING EFFECT**

This act shall take effect for sewer bills rendered on and after March 1, 2005.




