LOCAL LAW NO. 9 OF 1966

ENTITLED A LOCAL LAW AMENDING LOCAL LAW NO. 3 OF 1965 TO PROVIDE FOR CASH REIMBURSEMENT OF PAYMENTS MADE BY CITY EMPLOYEES AND RETIREES FOR MEDICARE COVERAGES.

BE IT ENACTED BY THE MAYOR AND COMMON COUNCIL OF THE CITY OF PLATTSBURGH, NEW YORK, AS FOLLOWS:

SECTION 1: SECTION 1 OF LOCAL LAW NO. 3 OF 1965 IS AMENDED TO READ FOLLOWS:


"SECTION 1 - THAT THE CITY OF PLATTSBURGH, PURSUANT TO AUTHORITY PROVIDED IN SECTION 92-A OF THE GENERAL MUNICIPAL LAW, SHALL PAY THE PREMIUMS FOR NEW YORK STATE HEALTH INSURANCE STATEWIDE PLAN, FOR REGULAR CITY OFFICIALS, DEPARTMENT HEADS, EMPLOYEES AND RETIRED EMPLOYEES, AND MEMBERS OF THEIR FAMILIES, EFFECTIVE ON AND AFTER MAY 1, 1965, INCLUDING PAYMENTS DIRECTLY TO RETIRED PERSONNEL OF THE CITY FOR WITHHOLDINGS FROM SOCIAL SECURITY PAYMENTS FOR MEDICARE PURPOSES OR PAYMENTS MADE DIRECTLY TO THE SOCIAL SECURITY ADMINISTRATION FOR MEDICARE.

SECTION 2: TIME OF TAKING EFFECT.

THIS ACT SHALL BE IN EFFECT AFTER PUBLIC HEARING AND APPROVAL BY THE MAYOR.


