Article IV.

Section 1. Place and Time of Board Meetings the Board will conduct regular monthly meetings on the Fifth Thursday of every month with five Thursdays, in the Common Council Chambers in City Hall. The meeting shall convene at a time set by the PMLD Chairperson pursuant to the notice provision of the Open Meetings Law.
