1. REPORT FROM CHIEF RITTER DETAILING CURRENT PARKING SYSTEM ENFORCEMENT STATISTICS FOR THE PAST MONTH

Chief Ritter discussed enforcement statistics for the month of February.

2. PROGRESS REPORT FROM CHAIR REGARDING OPTIONS TO REPLACE DURKEE LOT CAPACITY

There was a progress report of on-street and off-street parking replacement options. Discussion of the reconfiguration of streets such as Court Street, Oak Street and Brinkerhoff Street, to implement angled parking. Discussions of a parking structure continued. Further discussion around County parking needs. Discussion of pros and cons of angled parking. 3. DISCUSSION OF DRAFT RFP FOR PARKING KIOSK SYSTEM

Discussion: The committee went over a draft RFP for a parking kiosk system. Discussion involved the boundary of the parking kiosk boundaries to be based around the footprint of the current SAD. There was discussion about adding an alternation option in the RFP to expand the footprint of parking kiosk system to cover up to Miller Street to Lorraine Street. There was consisted over the technical requirements for any parking kiosks. Conversations occurred about what kind of payments the kiosks should accept. Discussions about the maintenance of the parking kiosks. Questions about how permit parking would interact with the parking permits. Conversations about the submission requirements, such the amount references. There was discussion on how scoring the RFP would occur.

Proposal: The footprint for the parking kiosk system described in the RFP would be conterminous with the boundaries of the current SAD, on both sides of the border streets, with an optional expansion to cover Miller Street up to Lorraine Street.
