QUESTIONS AND ANSWERS (including those from Pre-Bid Meeting)

Question 1: Is attendance at the Pre-Bid Meeting required?

Answer 1: No.

Question 2: Is the completion date set in stone? With testing 4 months is cutting the schedule close assuming contract is ready by Dec 1st.

Answer 2: The completion date of the project has been extended to June 1, 2026. The contract documents will be changed via this addendum to reflect the new completion date.

Question 3: On the previous project, there was a question about who is responsible for building up pads for drilling equipment? For PW-1 the City completed it. Will they also complete this for PW-2?

Answer 3: The contractor will be responsible for providing a stone working pad to complete the well installation. Pad size is as required by the contractor to complete the work. Changes will be made in the SITE AND SUBSURFACE CONDITIONS paragraph in the SPECIFICATION section. In addition, line item 2A was added to the Bid Form to account for this work.

Question 4: Is there a new road from the Mead Reservoir dam to the south of proposed PW-2 and if so, is this available for contractors to access the site?

Answer 4: Yes, the contractor will be able to use the new road from Mead Reservoir. The contractor will be responsible for any damage to the road or adjacent areas caused by their equipment. Changes will be made in the SITE AND SUBSURFACE CONDITIONS paragraph in the SPECIFICATION section.

Question 5: The bid documents state the project guarantee period is 5 years after completion in the warranty requirements section, however in the performance and payment bond area it says 1 year. 1 year is typical for a new water well. Please clarify.

Answer 5: The guarantee period will be 1 year.
