

Regular Meeting of the Common Council of the City of Plattsburgh, New York, held August 13, 1948.

LOCAL LAW NO. 13 of 1948.

ENTITLED AN ACT amending Local Law No. 6 of 1948 in relation to classification and minimum and maximum compensation for positions in the Department of Public Health.

BE IT ENACTED by the Mayor and Common Council of the City of Plattsburgh, New York, as follows:

Section 2 of Local Law No. 6 of 1948 is hereby amended by substituting for the sub-division entitled "Department of Public Health" the following:

The Dentist shall receive \$11.00 per clinic when employed.


The Public Health Nurse on School Duty shall be employed, and shall be entitled to compensation, only during the regular school year which comprises ten of the twelve months of the year excluding July and August. She shall be required to be on duty only during the days and hours of the regular sessions of the schools under her charge, which ordinarily amounts to about 200 days during the entire period covered by the school year. She shall be entitled to the usual time allowance for sick leave but shall not be entitled to vacation allowance as the period of her compensation includes vacatic time in addition to days on duty.

This Local Law shall take effect as of September 3rd, 1948, after Public Hearing and approval by the Mayor.

On roll call, Aldermen Holland, LeClair, Villoni, Croteau, Ryan and Cardi voted in the affirmative; no one in the negative, CARRIED.
