Bob Murphy, AICP; Leigh Jones, PLA; and Jeremy Hughes from Barton & Loguidice, DPC (B&L) hosted and facilitated the second Public Information Meeting for the Harborside Master Plan. The purpose of this meeting was to present a plan for the Environmental Learning Center and detailed site layouts for Harborside, and garner feedback from meeting participants. Mr. Murphy, Ms. Jones, and Mr. Hughes also discussed previously completed tasks of the project which included results from the virtual public meeting in February and results from the community survey.

The meeting was attended by 20 members of the public. The agenda was as follows:

1. Introductions, Ground Rules, and Project Team

Mr. Murphy walked the group through the agenda items before going through the evening's public information meeting ground rules. These included an explanation of the YouTube livestream, comments on the YouTube page, and the video recording and transcript for the hearing-impaired that will be made available.

2. Project Status and Timeline

The project timeline is on track. The Project Committee Kickoff, Public Workshop #1, Online Community Survey, and Public Workshop #2 having been completed.

The next steps of the project schedule includes:

- Public workshop #3: Final Designs Summer 2022;
- Draft Plan Summer 2022;
- CFA Grant Submission Round Summer 2022;
- Final Draft Plan Fall 2022; and
- CFA Grant Award Announcements Winter 2022.

3. Virtual PIM Summary and Survey Summary

The virtual Public Information Meeting was held on November 16, 2021. Its purpose was to introduce the project to the public as well as generate and get initial feedback on the inventory and analysis of the sites and the associated preliminary concepts.

The Online Community Survey was available to the public from January 14 to January 25. During that time, 1,094 people took the survey. Participants were asked a total of 18 questions about their ideas, priorities, and concerns about the future of Plattsburgh's Harborside site. The questions included a combination of multiple choice, ranking criteria, and some open-ended responses for issues or concerns not covered within the survey.

53% of participants said they don't visit Harborside because there isn't enough to do. The majority of participants (53%) stated they access Harborside Lakefront via Dock Street, with 22% using Green Street. 42% access the Riverfront Subarea via the Durkee Street Pedestrian Bridge.

65% of participants said they favor active recreation as high priority at the Lakefront. 54% favored whitewater recreation as high priority, while another 32% favored this as medium. 69% believe Harborside is lacking passive recreation. A popular open form comment was for Harborside to be appealing to people of all ages.

4. Detailed Site Layout Plans and Environmental Learning Center Plans

Mr. Murphy handed the presentation over to site design lead Leigh Jones (B&L). She described in detail the layout plans, features, and amenities through the Harborside Lakefront and Harborside Riverfront Subareas. This included preliminary concept plans based on committee feedback, relevant previous plans, and public input. Given some uncertainty regarding site control at the NYSEG site, recommendations were reduced in complexity and scope to reflect limitations on extension site development.





Mr. Murphy then briefed the public on the reasoning and background behind the Environmental Learning Center concepts and introduced City Environmental Resources Manager Jon Ruff to discuss the origins of the concept. Brian Jones (Aubertine & Currier) took over the presentation to describe initial layout of the Environmental Learning Center as well as models and renderings.

5. Committee Feedback and Discussion

The attendees were divided into groups to review the conceptual plans more closely, discuss proposed improvements, and provide feedback on the discussion boards created by the project team. The questions were split into two categories: Harborside Layout and Environmental Learning Center. Each category had four questions for the attendees to provide feedback and discuss. Participants were also provided with green dots to place next to things they liked and red dots to place next to things they did not like. They placed as many green and red dots as the wanted. They also placed comment cards on the boards.

Harborside Layout:

1. What features / amenities at Harborside should be top priority?

- Walking paths and views
- Playground areas
- Stage / entertainment
- Kayak / canoe / fishing access (concerns about long-term maintenance/costs)
- Whitewater course (concerns about overall costs and long-term maintenance/costs)
- Passive recreation and "sittable" spaces
- Other (please specify)

Comments included:

- Low maintenance should be a guiding principle of the design
- Active land use for kids (playground) with passive for adults
- Active water use

2. What groups of users does our design overlook? How so?

Comments included:

• Ensure overlooks are accessible, out over water.





3. In your opinion, how can Harborside be better connected to Downtown and nearby neighborhoods?

Comments included:

- Vehicular bridge from Cumberland Ave or City Hall Pl. to Harborside
- Connect pedestrian bridge from Macdonough Park
- Pedestrian bridge over tracks from train station on Bridge St down to site
- Mixed use development- housing and retail (grocery, drug store) would tie it together
- 4. What would make traveling to and from the Harborside area a more convenient and pleasant experience for pedestrians, bicyclists, boaters, and motorists?
