LOCAL LAW NO. 2 OF 1979

AN ACT AMENDING LOCAL LAW NO. 2 OF 1976 RESTRAINING RUNNING AT LARGE OF DOGS IN THE CITY OF PLATTSBURGH, NEW YORK, AND PARTICULARLY REGULATING DOG OWNERS RESPONSIBILITIES.

BE IT ENACTED by the Mayor and Common Council of the City of Plattsburgh, New York as follows:

 $\underline{\mathtt{SECTION}\ \mathtt{I}}.$ SECTION 3 of LOCAL LAW NO. 2 of 1976 is hereby amended to read as follows:

SECTION 3. A dog warden, a police officer, or a peace officer having reasonable cause to believe that a violation of this local law has been committed in his presence shall issue and serve an appearance ticket for such violation. The appearance ticket shall be in the form set forth at the end of this Section. An answer to such appearance ticket shall be made within five (5) days of the violation, by registered or certified mail, return receipt requested, in lieu of a personal appearance upon the return date at the time Court specified in the appearance ticket, in accordance with the provisions of Section 126 of the Agricultural and Markets Law and this local law.

SECTION 2. SECTION 6 of LOCAL LAW NO. 2 OF 1976 is hereby amended to read as follows:
SECTION 6. Any person who violates this law or knowingly permits the violation of this law or of any of the provisions thereof, shall be deemed to have committed an offense against this law and any person convicted of any such violation after investigation and hearing, shall be liable to a penalty of \$10.00 for the first violation; \$25.00 for the second violation; and \$50.00 for each subsequent violation.
SECTION 3. Except as herein amended, Local Law No. 2 of 1976
is in all respects ratified and confirmed.
SECTION 4. This Local Law shall take effect immediately after
public hearing and approval by the Mayor.
