AMENDING LOCAL LAW 1 of 1989
A local law REGULATING THE USE OF PUBLIC AND PRIVATE SEWERS AND DRAINS, PRIVATE SEWAGE DISPOSAL, THE INSTALLATION AND CONNECTION OF BUILDING SEWERS AND THE DISCHARGE OF WATERS AND WASTES INTO THE PUBLIC SEWER SYSTEMS AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF IN THE CITY OF PLATTSBURGH, CLINTON COUNTY, STATE OF NEW YORK.

Be it enacted by the Common Council of the

Section 10-4, Civil Penalties, amended and restated as follows:

Any user who is found to have violated an order of the Common Council or who willfully or negligently failed to comply with any provision of this Local Law, and the orders, rules, regulations and permits issued hereunder, shall be fined not less than \$1000 per day for each offense. Each day on which a violation shall occur or continue shall be deemed a separate and distinct offense. In addition to the penalties provided herein, the City may recover reasonable attorney's fees, court costs, court reporters' fees and other expenses of litigation by appropriate suit at law against the person found to have violated this Local Law or the orders, rules, regulations, and permits issued hereunder.
