LOCAL LAW NO. 4 OF 1970

ENTITLED AN ACT PROVINDING FOR THE MINIMUM AND MAXIMUM
COMPENSATION RATE AND OF ANNUAL INCREMENTS, AND THE TIME FOR
THE TAKING EFFECT OF SUCH INCREMENTS, FOR VARIOUS CITY PERSONNEL
IN THE FIRE DEPARTMENT OF THE CITY OF PLATTSBURGH, NEW YORK

BE IT ENACTED BY THE MAYOR AND COMMON COUNCIL OF THE CITY
OF PLATTSBURGH, NEW YORK AS FOLLOWS:

SECTION I. Compensation of the members of the Fire Department of the City of Plattsburgh.

The annual salary rates of the following City Officials and personnel shall be the amount shown below with the annual increments herein stated:

1. Upon completion of successive years of City Employment, the annual salary rate of each official, department head and employee listed in the salary and grade schedule of Section 1. shall be increased by one increment each fiscal year, in the respective amounts set forth in Section 1. Such salary rates resulting from said increments shall be effective beginning on the annual anniversary date of employment.

2. The annual salary rate of each official, department head and employee listed in the salary and grade schedule of Section 1 shall be increased by one increment, in the amounts established in Section 1 for the respective positions, upon completion of zero, one, two, three, four, five, seven, nine, twelve, fifteen, twenty and twenty-five years of consecutive employment by the City of Plattsburgh. Such salary rates resulting from said increments shall be effective beginning on the annual anniversary date of employment with the City of Plattsburgh provided

A. That such longevity increments shall be payable in consecutive order for zero, one, two, three, four, five, seven, nine, twelve, fifteen, twenty and twenty-five years of consecutive employment by the City, and that no one shall be entitled to more than one longevity increment step during any fiscal year.

SECTION 3. Promotions, Demotions, Transfers.

1. If a person is promoted, demoted or transferred, the salary paid shall be based upon years of service. In special cases, where the amount of increase is inadequate, the Mayor is authorized to adjust the new pay rate by an additional step.

SECTION 4. Part-time and Temporary Employment

The Common Council, or any other officer who may be so authorized or empowered by the Common Council, may employ person

SECTION 5. Supersession.


Provisions of all acts inconsistent with this Act are hereby superseded.

SECTION 6. Time of Taking Effect.


This Act shall take effect upon July 16 , 1970.


