

AT A REGULAR MEETING OF THE COMMON COUNCIL OF THE CITY OF PLATTSBURGH, N. Y., HELD MAY 7, 1964.

PRESENT: MAYOR TYRELL, ALDERMEN BEAUVAIS, DUKEN AND BRANON.

ABSENT: ALDERMEN BOOTH, SABOURIN AND FLYNN.

BY ALDERMAN BRANON; SECONDED BY ALDERMAN BEAUVAIS:

LOCAL LAW No. 5 of 1964

ENTITLED AN ACT AMENDING LOCAL LAW NO. 3 OF 1964 IN RESPECT TO WEARING APPAREL OF POLICEMEN AND POLICEWOMEN.

BE IT ENACTED BY THE COMMON COUNCIL OF THE CITY OF PLATTSBURGH, NEW YORK AS FOLLOWS:

SECTION 1: SECTION No.3 OF LOCAL LAW No.3 OF 1964 IS HEREBY AMENDED AS FOLLOWS:

SUB-DIVISION No.8 IN RESPECT TO TROUSERS SHALL PROVIDE THAT CAPTAINS AND LIEUTENANTS TROUSERS SHALL HAVE A ONE INCH (1") MOHAIR STRIP ON TROUSERS.

SUB-DIVISION No.17 IN RESPECT TO WEAPONS SHALL PROVIDE THE MINIMUM LENGTH FOR ALL OFFICERS TO BE TWO INCH (2") BARREL.

SUB-DIVISION No.19 SHALL PROVIDE THAT ALL RANKS IN THE POLICE DEPARTMENT SHALL USE BRASS BUCKLES AND FITTINGS.

IN RESPECT TO APPROVED CLOTHING AND EQUIPMENT FOR POLICE-WOMEN, PARAGRAPH 6, 7 AND 8 TO ALLOW EITHER A BLACK OR NAVY BLUE; PARAGRAPH 16 TO PROVIDE NAVY BLUE OR LEATHER FULL LENGTH WITH BADGE TAB.


SECTION 2. THIS ACT SHALL TAKE EFFECT AFTER PUBLIC HEARING AND APPROVAL BY THE MAYOR.
